Façade profiles with Colorpan surface are manufactured with great care using carefully selected materials. The manufacturing process and selection of the raw materials are based on over 35 years of experience in the production and use of WERZALIT products outdoors.

The core of the façade profiles is made of industrial timber that originates in Germany from PEFC-certified forestry operations. The Colorpan surface consists of a high-quality coating with especially light-fast pigments that have proven themselves in outdoor use for decades. Exclusively water-soluble coating systems are used. No solvents are used.

Through the controlled high-temperature drying of the acrylate system used, the mechanical and physical properties are further optimised to achieve high resistance to scratches and abrasion. The special material properties of the coating ensure high weathering resistance and outstanding resistance to embrittlement, even under high UV exposure and extreme weathering. The light fastness corresponds completely to level 8 according to DIN EN ISO 105-B02.

The WERZALIT warranty applies to the object defined below/the delivery defined below and is only valid in connection with the invoice or the purchase agreement.

Installation must take place strictly according to our guidelines as they existed at the time of purchase. In addition to the warranty of your supplier, WERZALIT provides the following warranty for the duration of 10 years from the invoice date:

If during the specified time period a defect arises in the product purchased from us that impairs the proper use of the product, we agree to, at our discretion, provide a replacement delivery, repair the product or reimburse the purchase price paid by you for those profiles that exhibit a defect.

This obligation presupposes proper installation in compliance with the WERZALIT guidelines and proper handling of the products delivered by us. Damages due to external influences or force majeure are excluded from this warranty.

Claims according to this warranty must be received by WERZALIT in writing within 10 years of the invoice date or, if no invoice was issued, as of the date of the written purchase contract with specification of the reason for the complaint (i.e. a description of the defect). For the processing of claims the employees assigned by WERZALIT must be granted prompt access to the object for which the complaint has been submitted.

Any services provided under this warranty shall not extend the original warranty period.

The sole place of jurisdiction for all claims submitted by merchants arising from this warranty is Stuttgart.
