

DECLARATION OF THE CYCLING TOUR PARTICIPATING IN THE MARCH _4a GERUNDA (hereinafter "La Marxa")

WHEN FORMALIZING THE REGISTRATION, I HAVE BEEN ADVISED OF THIS REGULATION AND I ACCEPT YOUR COMPENSATION. participates on the day _29 SEPTEMBER_ 2019 in La Marxa organized by _the Sport Ter_ Cycling Club (hereinafter "The Organizer") and declares:

I know the content of the Marcha regulations available on the website of L'Organitzador and I accept it in full.

That I declare that I have or will have the minimum age to participate in the course of the year of La Marxa, as detailed in article 2b of the Regulation of the Cycling Marks of the FCC.

I am aware that La Marxa is a cycling tour where competition is excluded and, in any case, there will be nothing similar to a competitive race.

Let La Marxa travel through public roads that are open to traffic and my traffic will respect the existing signaling and especially the indications of the agents of the civil protection and civil protection personnel and the Organization.

I accept the inherent risks involved in the route open to traffic.

That I commit myself to comply with the regulations of the Road Safety Law and its regulations, taking care of my security and that of the rest of the participants and users of the public thoroughfare.

I exempt the Organizer, its president, its board of directors, the Catalan Cycling Federation, and / or any natural or legal person linked to the organization of La Marxa of the responsibilities derived from any accident caused or for reasons related to the facts of the movement or for sports accidents.

I exempt those previously mentioned from any damage that, due to health reasons, could be derived from my participation in La Marxa, personally assuming the inherent risk to health that entails the physical effort required for participation in La Marxa.

That I declare to know the risks inherent to the participation in La Marxa, such as:

- Existence of all types of vehicles other than The Organizer circulating along the route of La Marxa.
- That these vehicles circulate between the cyclists like normal users of the tracks.
- I accept and know that I will find all kinds of vehicles circulating in both directions of circulation.
- I accept and know that there are cruises not regulated by the organization of La Marxa to which all types of vehicles can be incorporated.
- There are dangerous stretches in which I have to take precaution.
- There are declines that are prolonged with corners in which I will have to moderate the speed in order to avoid own and / or other damage.
- That there are stretches in which the state of the roads does not have the appropriate security conditions and I will exclude the Organizer from liability for any damage that I may have due to the bad preservation of the firm or as a result of defects in the road infrastructures.
- That there is a possibility of a sports accident linked to the practice of cycling, personally assuming the responsibility of accidents that I could cause to any participant in La Marxa, excluding the Organizer of any liability derived from these accidents.
- That there is the possibility of causing an accident to a third party outside of La Marxa, personally assuming the full responsibility of the aforementioned accident and excluding the Organizer from any liability derived therefrom.

The Organizer guarantees full compliance with the regulations on the Protection of Personal Data and, in accordance with Organic Law 15/1999, the participant is informed and consent to the incorporation of their data in the files Automated existing by the Organizer and the treatment of them for their use in relation to the execution of administrative, commercial and other activities.

Likewise, the participant accepts that the Organizer advises them information about news, managements or services that affect La Marxa. The acceptance of the participant so that their data can be treated or ceded in the form of this paragraph, is always revocable, without retroactive effect, as provided in articles 6 and 11 of Organic Law 15/1999 of December 13
